How to Sponsor and Create a Course?

- The general process is outlined below but we'll partner with you every step of the way.
- Contact us at programs@merchantriskcouncil.org or schedule a meeting with our education program manager here.
 - 1. **Contracting:** A small contract details your benefits and obligations.
 - 2. **Project Plan and Timeline:** We'll take the lead on project management and partner with you to create a plan and timeline for the launch of your course.
 - 3. **Content Creation:** Create a detailed course outline or PowerPoint with all course content included.
 - 4. **Instructional Design:** Our experts work with you to transform your information into an engaging eLearning course.
 - Review and Updates: Once complete, the course is sent to the MRC Education Committee for review. Recommended changes are made before final approval.
 - 6. **Launch:** The course is published and distributed via our RAPID Edu eLearning platform.
- Every 12 months, all online courses are reviewed for content freshness and information integrity. Any required updates are implemented at that time.
- After two years, you have the right of first refusal to update the course and continue the sponsorship of the chosen topic.
